

# Inquest into the deaths arising from the Lindt Café siege

## Non publication orders and access orders made by the State Coroner on 4 February 2016

1. Subject to the provision of an undertaking to the Court that they will only use or disclose the Emergency Action Orders and Deliberate Action Orders (**the Action Orders**) for the purposes of this inquest, the following people are to be given access to a copy of the Action Orders:
  - a. The legal representatives for the senior next of kin of Katrina Dawson;
  - b. The legal representatives for the senior next of kin of Tori Johnson;
  - c. The legal representatives for the person known as “Officer A” in these proceedings;
  - d. The legal representatives for the person known as “Officer B” in these proceedings;
  - e. the person known as “Officer A” in these proceedings; and
  - f. the person known as “Officer B” in these proceedings.
2. The Commissioner of Police is to provide to the Solicitor Assisting the State Coroner and the legal representatives for the Commonwealth a confidential summary of the contents of the Action Orders (**the Summary Action Orders**) by 5 February 2016.
3. Subject to the provision of an undertaking to the Court that they will only use or disclose the Summary Action Orders for the purpose of this inquest, the following are to be given access to a copy of the Summary Action Orders on 5 February 2016:
  - a. The legal representatives for the senior next of kin of Katrina Dawson;
  - b. The legal representatives for the senior next of kin of Tori Johnson;
  - c. The legal representatives for the person known as “Officer A” in these proceedings;
  - d. The legal representatives for the person known as “Officer B” in these proceedings;
  - e. the person known as “Officer A” in these proceedings;
  - f. the person known as “Officer B” in these proceedings;

4. Access to the Action Orders and the Summary Action Orders will be granted in accordance with Orders (1) and (3) in hard copy only, with each copy to be clearly watermarked to identify the recipient.
5. The copies of the Action Orders and the Summary Action Orders accessed in accordance with Orders (1) and (3) are not to be copied, electronically or otherwise.
6. The copies of the Action Orders and the Summary Action Orders accessed in accordance with Orders (1) and (3) are to be stored in a sealed envelope or secure container.
7. The copies of the Action Orders and the Summary Action Orders accessed in accordance with Orders (1) and (3) are to remain in Australia.
8. Until further order, pursuant to s.74(1)(b) of the *Coroners Act 2009* (NSW), there be no publication of the contents of the Action Orders and the Summary Action Orders.
9. Until further order, there be no disclosure by:
  - a. the State Coroner;
  - b. the legal and clerical team assisting the State Coroner;
  - c. Detective Chief Inspector Angelo Memmolo and his team of detectives assisting the State Coroner in this inquest; and
  - d. The individuals named at Order (3)(a)-(r).

of the contents of the Action Orders and the Summary Action Orders other than for the purposes of these proceedings.

10. Until further order, pursuant to s. 65(4) of the *Coroners Act 2009* (NSW) the Action Orders and the Summary Action Orders are not to be supplied to any person other than in accordance with these Orders.
11. The non-publication orders and access restriction orders made on 22 January 2016 continue to operate, notwithstanding these Orders.

12. The Court notes that the Commissioner of Police intends, at the hearing of this inquest, to make any application that he considers necessary to protect the public interest, including that this Court be closed in furtherance of these orders.
