

Inquest into the deaths arising from the Lindt Café siege

Orders made with respect to public interest immunity and access restriction and non - publication claims made by the Commissioner of New South Wales Police on 29 January 2016

1. With respect to the public interest immunity ('PII') claims made by the Commissioner of New South Wales Police, the following PII claims identified by reference to the schedule annexed and marked "A", and the column to the schedule titled 'PII claim number', are upheld:
 - a. claims 1 – 8;
 - b. claims 12 – 13;
 - c. claims 15 – 22; and
 - d. claims 27 – 31.
2. Pursuant to s. 65(4) of the *Coroners Act 2009* the information the subject of PII claims 9, 11 and 26A, identified by reference to the schedules annexed and marked "B", shall be received as confidential exhibits and is not to be supplied to any person except for the legal representatives of the Commonwealth of Australia and those persons instructing them.
3. Pursuant to s. 74(1) of the *Coroners Act 2009*, there is to be no publication of the information the subject of PII claims 9, 11 and 26A, identified by reference to the schedule annexed and marked "B".
4. Pursuant to s. 65(4) of the *Coroners Act 2009*, the information the subject of PII claims 10 and 26B, identified by reference to the schedule annexed and marked "C", shall be received as confidential exhibits and is not to be supplied to any person except for:
 - a. the legal representatives of the Commonwealth of Australia and those persons instructing them; and
 - b. the policing experts from the United Kingdom.
5. Pursuant to s. 74(1) of the *Coroners Act 2009*, there is to be no publication of the information the subject of PII claims 10 and 26B, identified by reference to the schedule annexed and marked "C".
6. Pursuant to s. 65(4) of the *Coroners Act 2009*, the information the subject of PII claim 14, identified by reference to the schedule annexed and marked "D", shall be received as a

confidential exhibit and shall be supplied to any person except for the following parties and their legal representatives:

- a. the family of Tori Johnson;
 - b. the family of Katrina Dawson;
 - c. Officer A;
 - d. Officer B; and
 - e. the Commonwealth of Australia.
7. Pursuant to s. 74(1) of the *Coroners Act 2009* there is to be no publication of the information the subject of PII claim 14, identified by reference to the schedule annexed and marked “**D**”.
8. Pursuant to s. 65(4) of the *Coroners Act 2009*, the information the subject of PII claims 1 to 22, and 24 to 31, as identified in the annexed schedules “**A**” to “**D**”, is not to be supplied to any person except for:
- a. the legal and clerical team assisting the State Coroner in this inquest;
 - b. Detective Chief Inspector Angelo Memmolo and his team of detectives assisting the State Coroner in this inquest; and
 - c. the legal representatives of the Commonwealth of Australia and those persons instructing them.
