

Inquest into the deaths arising from the Lindt Café siege

Non publication orders and access orders made by the State Coroner on 1 July 2016: Charlie 3 Walkthrough Video Extracts

1. These orders concern access to the following extracts of the 8 January 2015 “Charlie 3” Walkthrough Video (“**Charlie 3 Video Extracts**”):
 - a. Timestamp: 51.00 to 53.26 (as played in court on 30 June 2016);
 - b. Timestamp: 44.38 - 57.05.
2. Subject to the provision of a signed undertaking to the Court that they will **only** use or disclose the Charlie 3 Video Extracts for the purposes of this inquest, the following people are to be given access to a copy of the Charlie 3 portion:
 - a. the legal representatives for the senior next of kin of Katrina Dawson;
 - b. the legal representatives for the senior next of kin of Tori Johnson;
 - c. the legal representatives for the Commonwealth of Australia;
 - d. the legal representatives for the New South Wales Commissioner of Police;
 - e. the legal representatives for the person known as “Officer A” in these proceedings;
 - f. the legal representatives for the person known as “Officer B” in these proceedings.
3. Access to the Charlie 3 Video Extracts granted in accordance with Order (2) will occur through provision of the Charlie 3 Video Extracts material on disc, with each copy clearly numbered and marked to identify the recipient.
4. The copies of the Charlie 3 Video Extracts accessed in accordance with Order (2) are not to be copied, electronically or otherwise.
5. The copies of the Charlie 3 Video Extracts accessed in accordance with Order (2) are to be stored in a sealed envelope or secure container.
6. The persons listed in Order 2 (a) to (f) are permitted to give viewing access to persons permitted to be in closed court in this Inquest.
7. The copies of the Charlie 3 Video Extracts accessed in accordance with Order (2) are to remain in Australia.
8. Until further order, pursuant to s.74(1)(b) of the *Coroners Act 2009* (NSW), there be no publication of the contents of the Charlie 3 Video Extract.
9. Until further order, there be no disclosure by:
 - a. the legal and clerical team assisting the State Coroner;

- b. Detective Chief Inspector Angelo Memmolo and his team of detectives assisting the State Coroner in this inquest; and
- c. The individuals named at Order (2) and (6).

of the contents of the Charlie 3 Video Extracts other than for the purposes of these proceedings.

- 10. Until further order, pursuant to s. 65(4) of the *Coroners Act 2009* (NSW) the Charlie 3 Video Extracts are not to be supplied to any person other than in accordance with these Orders.
- 11. Within 14 days of the delivery of findings by the State Coroner in relation to this inquest, all copies of the Charlie 3 Video Extracts provided in accordance with Order (2) are to be returned to the solicitor assisting the State Coroner.
