

Inquest into the deaths arising from the Lindt Café siege

Non publication and access restriction orders made by the State Coroner on 15 March 2016

Until further order, pursuant to s. 74(1)(b) of the *Coroners Act 2009* (NSW):

1. There be no publication of the open affidavits numbered 1, 3, 7, 9 and 10 in 'Schedule A' to these orders, which were read by the legal representatives of the Commissioner of New South Wales Police ("**the Commissioner**") on 15 March 2016, in support of the Commissioner's public interest immunity claims.

Until further order, pursuant to s. 65(4) of the *Coroners Act 2009*:

2. The affidavits referred to in Order 1 not be supplied to any person, except for:
 - a. the State Coroner of New South Wales;
 - b. the legal team assisting the State Coroner in this inquest;
 - c. Detective Chief Inspector Angelo Memmolo and his team of detectives assisting the State Coroner;
 - d. the parties granted leave to appear at the inquest; and
 - e. the legal representatives of the parties granted leave to appear at the inquest.
3. The confidential affidavits and exhibits numbered 2, 4, 5, 6, 8 and 11 in 'Schedule A' to these orders not be supplied to any person, except for:
 - a. the State Coroner of New South Wales;
 - b. the legal team assisting the State Coroner in this inquest;
 - c. Detective Chief Inspector Angelo Memmolo and his team of detectives assisting the State Coroner; and
 - d. the legal team representing the Commissioner with respect to public interest immunity.
