Inquest into the deaths arising from the Lindt Café siege

Orders made by the State Coroner in chambers on 27 March 2017, 31 March 2017 and 6 April 2017 with respect to claims notified by the Commissioner of New South Wales Police on 10 March 2017 arising from the brief of evidence for the fourth segment
