

Inquest into the deaths arising from the Lindt Café siege

Orders made by the State Coroner in chambers on 12 December 2016 with respect to the transcript dated 7 July 2016

1. The public interest immunity claims made by the Commissioner of Police with respect to the following information on page 6461 of the transcript of proceedings dated 7 July 2016, are upheld:
 - a. the first five words of line 31;
 - b. the last two words of line 31; and
 - c. the first three words of line 32.
2. In accordance with the closed court, access restriction and non-publication orders made on the application of the Commissioner of the New South Wales Police Force, pursuant to s. 65(4) of the *Coroners Act 2009* (NSW), the following information contained in the transcript of the proceedings dated 7 July 2016 is not to be supplied to any person except for those persons listed in Schedule B to those orders:

 - s. the last word of line 44 on page 6541;
 - t. the first word of line 45 on page 6541;
 - u. the second to seventh words (inclusive) of line 30 on page 6543;
 - v. the last two words of line 12 on page 6545;
 - w. the last two words of line 18 on page 6545;
 - x. the last five words of line 16 on page 6547;
 - y. the words comprising lines 17 to 19 (inclusive) on page 6547;
 - z. the sixth to 11th words (inclusive) of line 24 on page 6547;
 - aa. the last word of line 42 on page 6547;
 - bb. the first five words of line 43 on page 6547;
 - cc. the last four words of line 50 on page 6547;
 - dd. the last 11 words of line eight on page 6548; and
 - ee. the first word of line nine on page 6548.
3. In accordance with the orders made on 22 March 2016, pseudonyms be inserted into the transcript of proceedings dated 7 July 2016 to replace the following words which contain the name(s) of a Category 1 officer(s) of the New South Wales Police Force, as follows:
- a. the fourth and fifth words of line nine on page 6467 be replaced with the pseudonym 'Sierra Three 1'; and
 - b. the ninth word of line 32 on page 6523 be replaced with the pseudonym 'Sierra Three 3'.
