

Inquest into the deaths arising from the Lindt Café siege

Orders made by the State Coroner on 28 June 2016 with respect to the transcript dated 27 May 2016 and in chambers on 27 March 2017, 31 March 2017 and 6 April 2017 with respect to claims notified by the Commissioner of Police on 10 March 2017

1.  - v. the tenth to 14th words of line 18 on page 4427; and
 - w. the last three words of line 24 on page 4427;
2. In accordance with the closed court, access restriction and non-publication orders made on the application of the Commissioner of the New South Wales Police Force, the following information contained in the transcript of the proceedings dated 27 May 2016 is not to be supplied to any person except for those persons listed in Schedule B to those orders:
