

# Inquest into the deaths arising from the Lindt Café siege

## Non-publication and access restriction orders made by the State Coroner on 16 May 2017 with respect to claims notified by the Commissioner of New South Wales Police arising from the submissions of Counsel Assisting

Until further order, pursuant to s. 74(1)(b) of the *Coroners Act 2009* (NSW):
