


Inquest into the deaths arising from the Lindt Café siege

Orders made by the State Coroner in chambers on 27 March 2017, 31 March 2017 and 6 April 2017 with respect to claims notified by the Commissioner of New South Wales Police on 10 March 2017 arising from the exhibits tendered during the fourth segment

1. In accordance with the closed court, access restriction and non-publication orders made on the application of the Commissioner of the New South Wales Police Force, pursuant to s. 65(4) of the *Coroners Act 2009* (NSW), the following information contained in the exhibits tendered during the fourth segment is not to be supplied to any person, except for those persons listed in Schedule B to those orders:
 - a. the name disclosed at 00:00:36 of Exhibit 36.13;
 - b. the words contained in the 'Document' column of the row numbered '8' in the index to the expert report of Dr Andrew Brown tendered as Exhibit 134;
 - c. the words following the number '7' under the heading 'Appendices' on page two of 43 in the expert report of Dr Andrew Brown tendered as Exhibit 134;
 - d. the last ten words of the third line of paragraph 8.4 on page 37 of 43 of the expert report of Dr Andrew Brown tendered as Exhibit 134; and
 - e. the words comprising the last two lines of paragraph 8.4 on page 37 of the expert report of Dr Andrew Brown tendered as Exhibit 134.
2. In accordance with the closed court, access restriction and non-publication orders made on the application of the Commissioner of the New South Wales Police Force, pursuant to s. 74(1) of the *Coroners Act 2009* (NSW), there is to be no publication of the document marked 'Appendix 7' to the expert report of Dr Andrew Brown tendered as Exhibit 134.
3. Pursuant to s. 74(1) of the *Coroners Act 2009* (NSW), there is to be no publication of the following information contained in the expert report of Dr Andrew Brown tendered as Exhibit 134:
 - a. page 13 of 43;
 - b. the text following all four bullet points on page 14 of 43;
 - c. the last seven words of the second line of paragraph 2.6 on page 25 of 43;
 - d. the first four words of the third line of paragraph 2.6 on page 25 of 43; and

- e. the fourth to seventh words (inclusive) of the penultimate line of paragraph 7.4 on page 37 of 43.
4. In accordance with the orders made on 22 March 2016, the pseudonym 'Graeme' is to be inserted into Exhibit 70 to replace the following words, which comprise the name of a Category 1 officer of the New South Wales Police Force:
 - a. the words comprising line four of Exhibit 70;
 - b. the second and third words of line eight of Exhibit 70;
 - c. the seventh and eighth words of the 12th line of Exhibit 70;
 - d. the last two words of Exhibit 70; and
 - e. the fifth word of the fourth line of paragraph 7.4 on page 37 of 43 of the expert report of Dr Andrew Brown tendered as Exhibit 134.
